FPCCI has the pleasure to invite applications for FPCCI Export Performance Awards for the year 2008-2009 (July-June). As you are aware these awards are considered highly prestigious at home and abroad and the recipients of FPCCI Awards now enjoy an exalted position in International Markets and have since built up a large volume of export business.

As per tradition, the Export Awards will be presented at a very impressive function attended by Senior Ministers, Top bureaucrats, Foreign Diplomats, leading businessmen and the Social Elite.

Applications are invited for following Categories of Awards, latest by **Saturday, October 10, 2009**.

### **1. PRESIDENT OF PAKISTAN AWARD**

The President of Pakistan Award will be given to a company whose overall export performance in value-added items is the highest in Pakistan. It may, however, be noted that a basic condition for this award is that each application (see Annexure C) shall be accompanied with Pay Order or Bank Draft of Rs. 340,000/= (Rupees Three hundred & Forty Thousands only), which shall be refunded to unsuccessful applicants, after deduction of 25% being processing charges.

### **2. BUSINESSMAN OF THE YEAR GOLD MEDAL**

(A) **Businessman of the Year Gold Medals** will be given to Leading Businessmen in the Categories of (1) **Investment** (2) **Total Taxes Paid**, by the company or group of companies (where the contestant has more than 51% or more share-holding) (3) **Foreign Exchange Earnings** (4) **International Trade Turnover** (5) **Percentage Increase in Exports** (6) **Marketing of New Brand(s)** (Copy of the Certificate from the Trade Mark Registry Office (in case of introduction of New Brand) (7) **Establishment of New Units / Industries**, during the year 2008-2009 (July to June). Complete documentation and proof / evidence in support shall be required for each category of Gold Medal:

Each Application (see Annexure C) in above categories shall be accompanied by Pay Order / Demand Draft of Rs. 290,000/= (Rupees Two hundred & Ninety Thousands only), which shall be refunded to unsuccessful applicants, after deduction of 25% being processing charges.

- (B) **Businessman of the Year Gold Medals (General Services)** will be given to Leading Businessmen & Service Providers in the Categories of (1) Insurance (2) Freight Forwarding (3) Logistics & Freight Services (4) Banking (5) Leasing (6) Buying Houses (7) Consultancy (8) Construction (9) Tourism (10) Inspection (11) Ports & Shipping (13) Hotel, during the year 2008-2009 (July to June). Complete documentation and proof / evidence in support shall be required for each category of Gold Medal:

Each Application (see Annexure C) in above categories shall be accompanied by Pay Order / Demand Draft of Rs. 290,000/= (Rupees Two hundred & Ninety Thousands only), which shall be refunded to unsuccessful applicants, after deduction of 25% being processing charges.

- (C) **Businessman of the Year Gold Medals (IT Services)** will be given to Leading Businessmen & Service Providers in the Categories of (1) Software Development (2) Web Development (3) Computer Marketing & Networks (4) Call Center (5) Telecommunication (6) Video Conferencing, during the year 2008-2009 (July to June). Complete documentation and proof / evidence in support shall be required for each category of Gold Medal:

Each Application (see Annexure C) in above categories shall be accompanied by Pay Order / Demand Draft of Rs. 290,000/= (Rupees Two hundred & Ninety Thousands only), which shall be refunded to unsuccessful applicants, after deduction of 25% being processing charges.

- (D) **Businessman of the Year Gold Medals (Corporate Social)** will be given to Leading Businessmen and Service Providers in the Categories of (1) Corporate Social Responsibility (2) Research & Development (3) Social Welfare (4) Sports & Culture (5) Health Care (6) Environment (7) Charity & Donation (8) Education & Training (9) Hospitals, during the year 2008-2009 (July to June). Complete documentation and proof / evidence in support shall be required for each category of Gold Medal:

Each Application (see Annexure C) in above categories shall be accompanied by Pay Order / Demand Draft of Rs. 290,000/= (Rupees Two hundred & Ninety Thousands only), which shall be refunded to unsuccessful applicants, after deduction of 25% being processing charges.

### **3. BEST REGIONAL EXPORTER AWARD**

FPCCI introduces this category of Awards to the Group of Companies / Companies, whose overall Exports is the highest during 2008-2009 (July-June) to the following Regions/Groups:

- (a) **ECO** (Afghanistan, Iran, Uzbekistan, Turkey, Tajikistan, Kazakhstan, Kirghiztan, Turkmenistan, Azerbaijan)

- (c) **North America** (Anguilla (UK), Antigua & Barbuda, Aruba (Netherlands), Bahamas, Barbados, Belize, Bermuda (UK), British Virgin Islands (UK), Clipperton Island (France), Costa Rica, Cuba, Dominica, Dominican Republic, El Salvador, Greenland (Denmark), Grenada, Guadeloupe (France), Guatemala, Haiti, Honduras, Jamaica, Martinique (France), Mexico, Montserrat (UK), Navassa Island (USA), Netherlands Antilles (Netherlands), Nicaragua, Panama, Puerto Rico (USA), Saint Barthelemy (France), Saint Kitts & Nevis, Saint Lucia, Saint Martin (France), Saint Pierre & Miquelon (France), Saint Vincent & the Grenadines, Trinidad & Tobago, Turks & Caicos Islands (UK), United States, US Virgin Islands (USA).
- (d) **South America** (Argentina, Bolivia, Brazil, Chile, Colombia, Ecuador, Falkland Islands (UK), French Guiana (France), Guyana, Paraguay, Peru, South Georgia & South Sandwich Islands (UK))
- (e) **ASEAN** (Indonesia, Malaysia, Philippines, Vietnam, Brunei, Cambodia, Laos, Myanmar, Singapore, Thailand)
- (f) **SAARC** (Sri Lanka, Afghanistan, Nepal, Bangladesh, Bhutan, Maldives, India)
- (g) **NAFTA** (Mexico, USA, Canada)
- (h) **African** (Brundi, Comoros, Djibouti, Eritrea, Ethiopia, Kenya, Madagascar, Malawi, Mauritius, Mayotte (France), Mozambique, Reunion (France), Rwanda, Seychelles, Somalia, Tanzania, Uganda, Zambia, Zimbabwe, Angola, Cameroon, Central African Republic, Chad, Congo, Democratic Republic of Congo, Equatorial Guinea, Gabon, Sao Tome & Principe, Algeria, Egypt, Libya, Morocco, Sudan, Tunisia, Western Sahara, Canary Islands (Spain), Ceuta (Spain), Madeira Islands (Portugal), Melilla (Spain), Botswana, Lesotho, Namibia, South Africa).
- (i) **Middle East** (Algeria, Bahrain, Egypt, Iran, Iraq, Israel, Jordan, Kuwait, Lebanon, Libya, Morocco, Oman, Palestine, Qatar, Saudi Arabia, Sudan, Syria, Tunisia, Turkey, United Arab Emirate (UAE), Yemen)
- (j) **Australia, New Zealand**
- (k) **China, Japan, Russia**

Each application (see Annexure C) in the above category shall be accompanied with Pay Order / Demand Draft of Rs. 250,000/= (Rupees Two hundred & Fifty Thousands only), which shall be refunded to unsuccessful applicants, after deduction of 25% being processing charges.

#### **4. BEST LADY EXPORTER TROPHY**

To encourage **LADY EXPORTERS**, FPCCI would give TROPHIES to those company/companies whose Chief Executive(s) / Proprietor(s) / Partner(s) is / are lady/ladies and has the credit of highest export performance in one item during 2008-2009 (July-June). The performance shall be judged on the basis of the exports of one single company and not of a group of companies.

Each application (see Annexure C) in this category shall be accompanied with Pay Order / Demand Draft of Rs. 250,000/= (Rupees Two hundred & Fifty Thousands only), which shall be refunded to unsuccessful applicants, after deduction of 25% being processing charges.

#### **5. BEST EXPORT PERFORMANCE AWARD**

The Best Export Performance Awards will be given to those Companies whose export performance in the Products / Items are the highest in Pakistan (see Annexure A).

Each application (see Annexure C) in the above category shall be accompanied with Pay Order / Demand Draft of Rs. 50,000/= (Rupees Fifty Thousands only), which shall be refunded to unsuccessful applicants, after deduction of 25% being processing charges.

#### **6. SPECIAL MERIT EXPORT AWARD**

Further, the FPCCI would give SPECIAL MERIT EXPORT AWARDS to those exporters, whether commercial or industrial, who earned foreign exchange equivalent to **Rs. 450 million or more** in any item during 2008-2009 (July-June).

Each application (see Annexure C) in the above category shall be accompanied with Pay Order / Demand Draft of Rs. 50,000/= (Rupees Fifty Thousands only), which shall be refunded to unsuccessful applicants, after deduction of 25% being processing charges.

#### **7. MERIT EXPORT AWARD**

FPCCI will award MERIT EXPORT AWARDS TO ENCOURAGE AND PATRONIZE THE EXPORTERS OF NEW AND NON-TRADITIONAL ITEMS/MARKETS. The minimum export performance in **this category will not be less than Rs. 40 million**. In case of introduction of a new (non-traditional) item whose exports have been made to a new market, the Federation reserves the right to consider application of such exporters even for less than Rs. 40 million export performances.

Each (see Annexure C) application in the above category shall be accompanied with Pay Order / Demand Draft of Rs. 50,000/= (Rupees Fifty Thousands only), which shall be refunded to unsuccessful applicants, after deduction of 25% being processing charges.

#### **8. MERIT EXPORT AWARD for Women Entrepreneurs**

In addition, it has been decided that FPCCI will award MERIT EXPORTER AWARDS TO ENCOURAGE AND PATRONIZE THE LADY EXPORTERS OF NEW AND NON-TRADITIONAL ITEMS/MARKETS. The minimum export performance in **this category will not be less than Rs. 10 million**, the Federation reserves the right to consider application of such exporters even for less than Rs. 10 million export performance.

Each application (see Annexure C) in the above category shall be accompanied with Pay Order / Demand Draft of Rs. 30,000/= (Rupees Thirty Thousands only), which shall be refunded to unsuccessful applicants, after deduction of 25% being processing charges.

*Note: Each applicant for the FPCCI's Awards for **Best Export Performance** / **Special Merit Export** / **Merit Export** will be required to furnish its export performance in accordance with the Proforma (see Annexure D) and pay application fee in the form of Bank Draft or Pay Order drawn in favour of the FEDERATION OF PAKISTAN CHAMBERS OF COMMERCE AND INDUSTRY. Only those companies will be eligible for award, which apply in the prescribed manner and pay Application fee.*

FPCCI AWARDS FOR 2008-2009 (JULY-JUNE) WILL BE GOVERNED BY THE RULES AND REGULATIONS FRAMED BY FPCCI IN THIS BEHALF. **A COPY OF THE RULES AND REGULATIONS APPROVED BY THE COMPETENT AUTHORITY OF FPCCI IS ENCLOSED HEREWITH FOR GUIDANCE AND COMPLIANCE** (see Annexure B).

FPCCI SEEKS THE EARNEST COOPERATION OF ITS MEMBER BODIES FOR WIDE CIRCULATION OF THE ABOVE INFORMATION AMONGST THEIR MEMBERS ON AN **URGENT BASIS** THROUGH A SPECIAL CIRCULAR WITH THE ADVICE THAT THOSE INTERESTED TO PARTICIPATE IN THE COMPETITION MAY SEND THEIR APPLICATIONS (see Annexure C) ALONG WITH ALL THE REQUIRED DOCUMENTS AND FEES TO FPCCI HEAD-OFFICE, KARACHI "**LATEST BY SATURDAY, OCTOBER 10, 2009**" FOR CONSIDERATION BY THE AWARDS COMMITTEE OF FPCCI. PARTICIPANTS WHO APPLY AS PER PROFORMA ENCLOSED AND WITHIN THE STIPULATED TIME; SHALL BE CONSIDERED ELIGIBLE AND QUALIFIED BY THE COMMITTEE FOR CONSIDERATION OF THE AWARD ON MERIT.

**BEST EXPORT PERFORMANCE AWARD / SPECIAL MERIT EXPORT AWARD AND MERIT EXPORT AWARD**  
**(FOR THE YEAR 2008-2009 (JULY - JUNE))**

1. Applications for participation in the FPCCI Export Award for 2008-2009 shall be submitted on the prescribed form, the specimen of which has been furnished to all constituents of FPCCI.
2. Each application for Best Export Performance / Merit Export / Special Merit Export Award should be accompanied with the Application fee of Rs. 50,000/= (Rupees Fifty Thousands only) in the form of Bank Draft/Pay Order drawn in favour of the FEDERATION OF PAKISTAN CHAMBERS OF COMMERCE & INDUSTRY, which shall refunded to unsuccessful applicants, after deduction of 25% being processing charges.
3. The Firms/Companies or Business Houses, which are selected for FPCCI Awards / Trophy for 2008-2009 shall remit to FPCCI an amount in the shape of pay order or demand draft as per the following slabs:
 

Best Export Performance Award:	2,40,000/-
Special Merit Exporter Award:	2,15,000/-
Merit Exporter Award:	1,90,000/-
Merit Exporter Award for Women Entrepreneurs:	1,85,000/-
4. The Firms/Companies or Business Houses, which are selected for President of Pakistan Award for 2008-2009 shall remit to FPCCI an amount of Rs. 1,600,000 in the shape of pay order or demand draft.
5. The Firms/Companies or Business Houses, which are selected for the following categories are required to pay Rs. 600,000/= (Rupees Six hundred thousand) each through pay order or demand draft favouring "The Federation of Pakistan Chambers of Commerce & Industry (FPCCI)".
  - I. Businessman of the Year Gold Medal (Export, Services, Info-Tech & CSR).
  - II. Best Regional Exporter Award
  - III. Best Lady Exporter Trophy.
4. Each applicant shall submit detailed statement showing Volume/Value of Exports along with the prescribed application form duly filled in for the period 2008-2009 (July-June) in respect of the concerned item(s) only, authenticated and verified by the concerned bank(s). The application should be supported by the following documents:
  - I. FPCCI Application Form duly filled in.
  - II. Bank Certificate duly attested by two Bank Officers.
  - III. FPCCI Export Awards Pro-forma duly attested by the concerned bank(s).
  - IV. Application fee through Demand Draft / Pay Order favouring "The Federation of Pakistan Chambers of Commerce & Industry".
  - V. Form "E" (on requisition/demand, if necessary).
  - VI. Bill of Lading (B/L) (on requisition/demand, if necessary).
5. The Award will be given exclusively on the INDIVIDUAL PERFORMANCE of the company competing for the Award, except for the Best Regional Exporter Award.
6. The Export Award shall be received by the Chairman, Chief Executive, Proprietor or Director of the recipient Company/Firm, in the FPCCI Export Awards Function.
7. Selection of Award Winners will be made by a Committee constituted by the Competent Authority of FPCCI.
8. It is compulsory for each Export Award Applicant after selection, to give one FULL PAGE COLOR Advertisement in FPCCI Souvenir. Those companies who have selected for two categories of awards on special circumstances, they may be allowed to pay for one Advertisement. The rates of which are as under:

9. If a company applies for two awards, then FPCCI may have the right to consider for one Category of the Highest Award.
10. If a company fails to complete all the requirements of the awards, FPCCI has the right to reject or accept the company for the award by the approval of competent authority.
11. Once the selection for the award is made or the letter of selection is issued to the company, the entire amount deposited will become non-refundable under all circumstances.
12. The decision of the FPCCI with regard to the selection of Award Winner shall be final and binding on all concerned and it shall not be challengeable / contestable in any court of law. FPCCI reserves the right to accept or reject any application for FPCCI Awards without assigning any reason.
13. The FPCCI reserves the right to demand any further proof regarding the documents submitted in support of the claim of the awards.
