SUBJECT	KINGDOM OF SAUDI ARABIA'S MEGA RAILWAY EXPANSION PROGRAMME
FROM	Saudi Arabia

DESCRIPTION	They are inform you that the Ministry of Transport, Government of Saudi Arabia has initiated billions Dollars railway expansion programme, which has mainly two projects: (i) Saudi Landbridge Project, which Connects Jeddah (Red Sea) to Dammam (Gulf) (ii) Haramain High Speed Rail, which will linking Makkah and Madinah to western port city of Jeddah. Saudi Landbridge Project involves the construction of 950 Km of new tracks between Riyadh and Jeddah and a 115 Km line linking Damam and Jubail. The Saudi Government plans to have 3 railway sectors i.e., Jeddah – Damam, Damam-Qaseen and Jeddah-Makkah-Madina circular railway projects. This project, the Middle East's largest ever rail project, costing US\$ 2 billion (SR 75 billion), is to be split into four main contracts comprising earthworks and bridges, ballast and track installation. Hermain High Speed Rail (Makkah-Madina Rail Link Project) involves construction of approximately 450 Km of new railway line between Makkah and Madina. This Project has two phases. The second part of first phase involves building of stations, construction of which will commence tentatively by June 2009.
